D-New Business

D-1 Frank DeMarinis, PE wished to speak before the Board to discuss the restrictions on an engineer stamping architectural portions of plans, on what is defined as incidental to his P.E. certification, and would like to dialogue on specific examples and standards.

Mr. DeMarinis spoke to the Board regarding plans that were submitted to a town in which the Building Official was not certain whether or not he should require an architectural seal. Mr. DeMarinis was seeking guidance from the Board about whether or not the design he prepared constitutes architecture.

Resolution was that the Board could not determine whether the engineer is qualified to do architecture work that is incidental. The professional engineer must prove to the satisfaction of the building official that he or she is qualified through his or her experience to design the various components of the building.

Therefore, Mr. DeMarinis was advised to provide a copy of Chapter 390, Section 22-98 along with his resume showing that he has performed this type of work numerous times, to the Building Official.
