The Head Moderator shall complete, sign, seal and deliver **one set** of such returns electronically to the Secretary of the State not later than **forty-eight hours** after the close of the polls and then deliver **one such original** return to the Secretary of the State **not later than the third day after the election** and deliver the other set to the Town Clerk.
