

## **Agenda of Regular Meeting**

(May 8, 2013)

A regular meeting of the Public Utilities Regulatory Authority (Authority) and/or staff members of the PURA will be held in the offices of the Authority, Ten Franklin Square, New Britain, Connecticut, on Wednesday, May 8, 2013 at 9:30 a.m. concerning the following:

1. Consideration of the following Draft Decisions:

Docket No. 04-09-01 - Application of Digizip.com, Inc. for a Certificate of Public Convenience and Necessity (BCH);

Docket No. 07-03-08RE02 - Application of Constellation Energy Power Choice, Inc. for a License as an Electric Supplier – Five Year Renewal. (CBH);

Docket No. 13-01-12 - Application of Georgia Mountain Community Wind LLC for Qualification of Georgia Mountain Community Wind as a Class I Renewable Energy Source (CBH);

Docket No. 12-11-24 - Application of Single Source Energy Solutions, Inc. for a Certificate of Registration as an Electric Aggregator (CHB); and

Docket No. 13-03-06 - Application of Valley Water Systems, Inc. for Approval to Increase and Refinance its Existing Long Term Debt (CBH).
